Based on your request, certification, and the evaluation of your 2019-2020 catalog and accompanying documents received November 24, 2019 continuing approval is extended to Central Baptist Theological Seminary for the training of veterans and other eligible persons under laws administered by the U.S. Department of Veterans Affairs.
